Privacy Policy

This Privacy Policy describes how **FPL Pro Manager** ("we," "us," or "our") collects, uses, and discloses your personal information when you use our **mobile application** and related services.

1. Information We Collect

We may collect personal information that you voluntarily provide when you register for the league or interact with our App. This information may include :

- **Contact Information:** Name, email address.
- **FPL-Related Information:** Your Fantasy Premier League team ID or public username, provided for integration with the FPL Pro Manager League.
- **Communication Data:** Any information you provide when contacting us for support or inquiries.

2. How We Use Your Information

We use the information we collect for the following purposes:

- To facilitate your participation in the FPL Pro Manager private league.
- To communicate league updates, news, and important announcements via email or in-app messaging.

- To provide customer support and respond to your inquiries.
- To improve and optimize the performance, features, and user experience of the App.
- To monitor and analyze usage trends, engagement, and preferences.
- To comply with legal and regulatory obligations.

3. Sharing Your Information

We may share your information with third parties in the following circumstances:

- **Service Providers:** Trusted third-party vendors who perform services on our behalf, such as cloud hosting, analytics, email delivery, and customer support platforms.
- **Legal Requirements:** When required by law, or in response to valid requests from public authorities (e.g., court orders or government agencies).
- **Business Transfers:** In connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or part of our business.

4. Data Security

We implement reasonable administrative, technical, and physical security measures to protect your personal information from unauthorized access, use, or disclosure. However, no method of transmission over the Internet or electronic storage is 100% secure. While we strive to protect your data, we cannot guarantee absolute security.

5. Your Data Protection Rights

For material changes, we will provide at least **30 days' notice** via email or in-app notification, where feasible. Your continued use of the App after the changes become effective constitutes acceptance of the updated policy.
